

# Accommodation Rules

---

- Accommodation order follows the contract for accommodation, which formed the client (hereinafter referred to as the guest or the resident) the right to his landlord provide temporary accommodation for a period agreed on the order of stay.
- The guest is obliged to get acquainted with the house rules Recreational center Palda and obey staying in this house rules and guidance staff.
- For accommodation and related services, the guest is obliged to pay the accommodation provider the agreed price within the period as required by landlords who may demand payment for accommodation in advance. The balance is payable upon presentation.
- The guest has the right to use the premises reserved for accommodation and public areas, and use the services that are associated with accommodation. The guest is not authorized to perform in these areas without the consent of the Landlord make any changes, move furniture or other objects, make repairs, etc.
- The landlord is obliged to give the guest space reserved for accommodation in a state fit for proper use (housing) and keep him undisturbed for his rights related to accommodation.
- Damage to equipment or facilities the guest is obliged to inform the reception area.
- The guest is responsible for any damage caused by his fault the Landlord's property and shall pay those damages.
- If accommodated guest requests, the landlord will take over from a guest into custody, cash and other valuables. This provision does not apply if it is a dangerous thing, or things, or the value range for accommodation disproportionate. Things transferred to the custody must be submitted in a closed and sealed case. The acceptance of the goods to be drawn up for safekeeping.
- Guests at the onset of the hotel accommodation fills a ticket if information is not already listed in the order of stay. The landlord guest registers and writes to registration (house) books to the extent required by Act on local charges (levying of accommodation, resort fee)
  - Date of birth (the figure for the charge)
  - Time and purpose of stay (weekend stay)
  - Name, last name, place of residence (in accordance with the law on privacy), number of ID card or passport
- Other essentials charging is governed by Decree city on local charges.

- The guest has the right to stay on an order at 14 to 18 hours. The landlord in this time room for the guest reserves, unless otherwise agreed. Earlier or later arrival or departure at the accommodation has to be arranged in advance.
- Accommodated guest is entitled to terminate the contract for accommodation before the end of the agreed term contract, is obligated to compensate the Landlord damage which he suffered as a result of early cancellation of accommodation by the Resident.
- Unless the period of accommodation arranged otherwise in advance, logs (closes) guest stay between 8 and 10 pm., At the latest by 10 am on the last day of accommodation, at the same time and room released. If you do not stay logged a guest in this period, you may charge the landlord and stay for the next day.
- The guest, which houses before 6 am shall pay the price of accommodation for the whole preceding night.
- The guest who ordered accommodation before 12 am and ordered him room the previous night could not be hired will pay accommodation for the previous night.
- If a guest asks for an extension of accommodation, the landlord may offer him a different room (holiday house) than the one in which it was originally housed.
- In the time from 22 am to 6 pm, guests comply with curfews.
- The room (cottage, apartment) can receive visitors only with the consent of the accommodation (after writing in the guestbook at the reception), from 8 to 22 hours.
- Taking accommodation (room, cottage, apartment) is only permitted for persons who do not suffer from infectious diseases. When illness or injury guest landlord provide medical assistance or transportation to a hospital.
- Guest are not allowed to use the room's own electric or gas appliances except for appliances used personal hygiene (shaver, hairdryer, massager) or personal need (laptop, printer, battery chargers, mobile phone).
- Host when leaving the room (cottage, apartment) closes the window, or taps, turn off electrical appliances, lights go down and the room is locked.
- Not allowed to leave children under 6 years in the room (cottage, apartment) and other social areas campus without adult supervision. Parents are responsible for their children's behavior in all areas of the resort.
- Youth under 18 years of age is prohibited from all areas of the center to serve and consume alcohol, enjoy narcotics or smoke.
- Sports games may be operated only on the playground or in a designated area.

- The landlord is responsible for damage to things that were guests or for them brought into restricted areas of the hotel. If it is proved that the damage would have occurred otherwise, or that damage helped host himself or his surroundings, the landlord is relieved of responsibility. Introduced the things that were brought into the area designated for guests or to store things, or that were submitted for the purpose of the accommodation (accommodation to the worker at the reception).
- Dogs, cats and other animals may be in the accommodation facility only with the prior consent of the Landlord, if the guest and prove their good health. Pets in the apartments is expressly prohibited.
- Animals must not use beds, bathrooms, showers, should not run loose in the area may not be within walking in the area can only be the owner and on a lead. Animals shall not be closer to the children's corners, playground. If accidentally become execution dog supplies, it is necessary to remove and clean up the excrement into the bag, which is in the area available.
- All guests are required to garbage stored in designated garbage bins.
- Fires are allowed only in designated areas.
- Cooking and washing is allowed only in a common kitchen.
- Parking vehicles in the car park at the reception is only permitted for a period necessary for the processing of staying in the office reception. There is only allowed to park in reserved parking, buses parked on the hard surface of the off-campus reception.
- It is not permitted to pass through motor vehicle area, retraction to individual objects, except for meadows camping or camping.
- There is allowed a maximum speed of 5 km per hour.
- For cycling on campus can only use marked paths, ride and walk through the planting of greenery and flower beds is prohibited.
- The landlord can from the contract for accommodation prematurely terminate without notice and before the expiry of the agreed period of accommodation if the host in the area despite the warning or alarm violates good manners or otherwise violates its obligations under the provisions of the House Rules.
- Any complaints and suggestions for improvements accepts landlord or persons authorized by the reception area.
